- Copies of any applications, contracts, agreements, correspondence, including letters and emails, orders or other documents from 2009 and 2010 the U.S. Army or its representatives had with the Billy Graham Evangelical Association related to hosting the September 25, 2010, "Rock the Fort" event.
- 2) Copies of any applications, contracts, agreements, correspondence, including letters and emails, orders or other documents from 2009 and 2010 the U.S. Army or its representatives had with any vendor or contractor related to hosting the September 25, 2010, "Rock the Fort" event, including, but not limited to, those who supplied security, parking, food, tents, entertainment, event management, advertising, marketing, sound, stage, event set-up and tear down, sanitation, or any other related services.
- 3) Copies of any applications, contracts, agreements, correspondence, including letters and emails, orders or other documents from Lieutenant General Frank G. Helmick authorizing the Billy Graham Evangelical Association to host the September 25, 2010, "Rock the Fort" event, including, but not limited to, authorization for the use of Fort Bragg facilities, equipment, utilities, or personnel.
- 4) Copies of any applications, contracts, agreements, correspondence, including letters and emails, orders or other documents sent or received by Lieutenant General Frank G. Helmick, the Religious Support Office, or the Billy Graham Evangelical Association that includes reference to the content, planning or execution of the September 25, 2010, "Rock the Fort" event.
- 5) Copies of any advertising, marketing or promotional materials used to promote the September 25, 2010, "Rock the Fort" event, including, but not limited to, flyers, posters, newsletters, print advertisements, web content, or documents sent to any churches or religiously-affiliated institutions.

- 6) Copies of any receipts, invoices, billing statements, or other documents sent to the Billy Graham Evangelical Association or any vendor or contractor, including, but not limited to, those who supplied security, parking, food, tents, event management, advertising, marketing, sound, stage, event set-up and tear down, sanitation, or any other related services, for the use of Fort Bragg facilities, equipment, utilities, or personnel.
- 7) Copies of any applications, contracts, agreements, correspondence, including letters and emails, orders or other documents related to increasing military or civilian staffing at Fort Bragg due to the September 25, 2010, "Rock the Fort" event.
- 8) Copies of U.S. Army policies and/or procedures on hosting religious events or any other document that lays out the steps a religious organization or church must take to host an event on the Fort Bragg installation.
